Poll Results of 2018 Annual General Meeting

The Company's Annual General Meeting (AGM) was held today, Tuesday 13 November 2017 at 11.00am (AEST).

The Board is pleased to announce that all of the resolutions as set out in the Notice of Meeting dated 12 October 2018 were duly passed by shareholders by way of a poll at the AGM.

As at the record date of the AGM on 9 November 2018, the total number of Shares on issue was 1,175,811,066 Shares.
